Who is eligible for funding and what are the requirements?

Any full time employee of the business is eligible for funding if they meet all of the following requirements:

- ✓ Must be an Australian resident
- ✓ Must be at or below a Diploma level of education

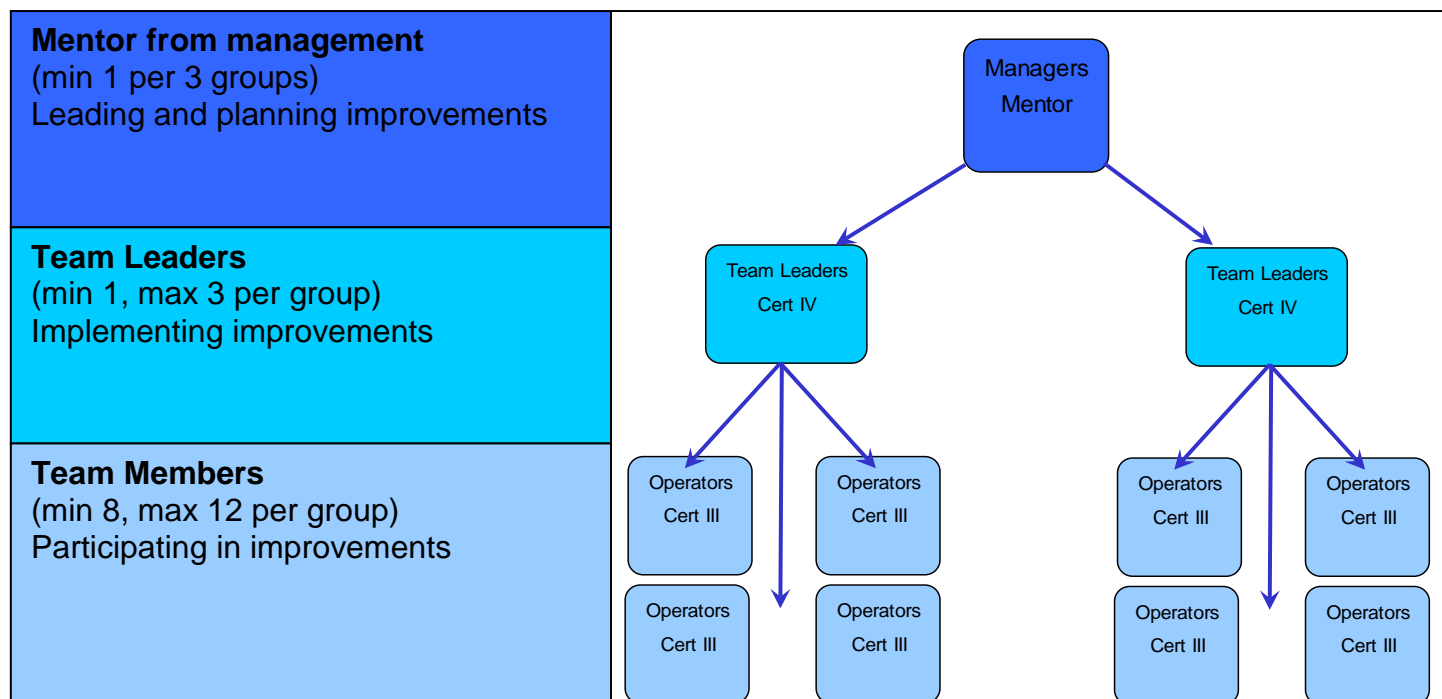

How is the training structured?

- ✓ Company has the option to select any 2 lean projects for implementation (Generally 5S is project 1)
- ✓ Training is delivered in a structured manner at a schedule agreed to by the company
- ✓ Group sizes are minimum 10 and maximum 15
- ✓ 10 x two-three hour sessions, once per month (50% theory plus 50% application in workplace)
- ✓ An additional 6 hours of support, per session, is provided by the trainer for project management and implementation (1 day per trainer per group)
- ✓ Trainees practice new skills as part of normal work for a minimum 3 hours per week

How is the program implemented?

Vative have extensive experience with successful improvement and change programs. Solutions are tailored to your needs. Our programs are generally delivered in the following format:

1. Project discussion about business needs and objectives
2. Process tour with project manager/trainer
3. Sign up of trainees
4. Course induction and introduction to handbooks and course
5. Cultural/Morale Survey assessment 1
6. Value Stream Mapping of business processes (1 product either highest volume or value)
7. Lean Business Health Check (LBHC) (only if 2 or more groups)
8. Strategic assessment results presentation to management
9. OHS, Environment & Communication
10. Project 1 implemented and presented to management together with 5S (over 9 sessions, one/month)
11. Cultural/Morale Survey assessment 2
12. Quality Assessment
13. Post Training Lean Business Health Check (only if 3 or more groups)
14. Presentation of certificates and business summary
